# WHICH COUNTRY IS THE RICHEST IN EUROPE?








## The answer is Luxembourg

Luxembourg is the richest country in the European Union based on the GDP per capita indicator for the average GDP of all EU countries. This indicator, converted into purchasing power parity (PPP), in Luxembourg is six times higher than the same indicator for Bulgaria, the poorest country in the bloc (283% vs. 43%). At the same time, the average GDP per capita (PPP) in the euro area is at 108%.









Over the past year, the **GDP** of Luxembourg amounted to 59.475 million dollars, the country ranked 69th in the world ranking, bypassing Sri Lanka and Syria. GNI per capita is high and is 78130 dollars.

In the last 10 years, Polish economy grew constantly and never reached negative value. Poland's growth has been based primarily on 5 pillars:


- 1. dynamic exports,

3) it has an excellent transport infrastructure that would link it to the rest of Europe.















Unit: Gross weight in million metric tons










# Which country is the world's second producer of cars (after Japan) and motor vehicle in general (after the USA)?

- 3. Volkswagen group is largest automotive company in Germany










### Automobile production in Germany from 2007 to 2019 (in millions)

- advanced ecosystem of Switzerland


